In light of the revised statute for the scheme of rotation of Headship Vide BSU-26/2008-2155/GS(I) dated 30th June 2008, the Governing Body has decided vide Resolution no. 3 dated 01.06.2025 to implement the following provisions for Headship rotation scheme from date of notification.

- (i) Headship of the Deptt. be rotated only amongst the first four senior most teachers (Professors and Readers) as the case may be of the subjects concerned.
- (ii) Where there is no Professor, the Headship shall be rotated amongst the four senior most Readers, or less if the number of Readers in the Deptt. is less than four.
- (iii) If there is neither a Professor nor a Reader in the Deptt. the Headship of the Deptt. may be rotated amongst teachers of the Deptt.
The tenure of Headship of the Deptt. will be for three years. If for any reason, the Secretary feels that change in the Headship of the Deptt. even prior to the completion of term of existing incumbent, is necessary in the interest of the Deptt. change in the Headship of the Deptt. be made subject to the approval of the Governing Body.
- (iv) During the period of absence or leave of the duly appointed Head of the Deptt. the next senior most teacher in the Deptt. shall carry on the office of the Head of the Deptt. provided that if the absence extends over a period of three months or more, the Secretary may keeping in view the circumstances entrust the work to the next senior teacher in the subject. If however, the vacancy in the office of Head of the Deptt. is to last or likely to last over a period of one year or more, the Secretary may appoint another Head of the Deptt. in accordance with these rules in the vacancy.
- (v) If there is only one teacher in a department, he/she can not claim headship and hence there will be no head in that department.
- (vi) If there is a teacher who is due to retire within one year of time, he/she shall not be appointed as Head of the Deptt. and the next senior teacher in the subject will be appointed as the head of Deptt.
